

KanCare Expansion: Just the Facts

KanCare expansion is good for patients and public health.

Expansion substantially increases coverage, improving access to all health care services, including preventive care, primary care, and prescription drugs. Although it takes many years to determine the effects of most policy and clinical interventions on health, the evidence on the positive health effects of Medicaid expansion continues to grow.

- Medicaid expansion is associated with substantial increases in coverage, use of services, and quality of care.^{1,2,3}
- Medicaid expansion saves lives. Expansion is associated with decreases in mortality for all causes, as well as improvements in infant mortality and survival among patients with end-stage renal disease.^{4,5,6} Enhanced spending on prescription drugs under Medicaid is also shown to reduce mortality.⁷
- Medicaid expansion directly enhances preventive care, resulting in improved rates of glucose monitoring and access to insulin and other medications for patients with diabetes, better hypertension control, improved rates of prostate and breast cancer screening, and higher rates of Pap testing.^{8,9,10}
- Medicaid expansion greatly enhances use of services for mental health and substance use disorder (SUD) and enables states and providers to offer new services. These are particularly critical needs in Kansas in light of care and capacity issues at Osawatomie and Larned State Hospitals and the alarming growth in opioid and other substance use disorders.^{11,12,13,14,15,16}
- Residents of expansion states report reductions in psychological distress and days of poor mental health, as well as increases in self-assessed general health.¹⁷
- Expansion enables states to connect ex-inmates to health coverage, address their mental health or SUD needs, and reduce recidivism.¹⁸
