### Overview



#### **Background:**

The budget bill currently being considered in the U.S. Senate would kick nearly 11 million people off their health insurance, including cancer patients, survivors, and their families.

Not only does the bill drastically slash Medicaid funding, but it would also raise health care costs for everyone—even those with private insurance. The cost of health care is already far too high, and passing this bill is the last thing Senators should do for the people they represent.

Because of you, the impact of the May Medicaid Day of Action was seen far and wide and your messages reached U.S. Representatives. Now, we need your help to do the same to reach U.S. Senators.
